



## DIVERSIFIED OCCUPATIONS ARTICULATION AGREEMENT

BETWEEN

LACKAWANNA COLLEGE

AND

WEST SIDE CAREER & TECHNICAL CENTER

### PURPOSE:

This Articulation Agreement (this "Agreement") is valid effective April 1, 2021 and remains in force for one (1) year.

West Side Career & Technical Center ("WSCTC") and Lackawanna College ("LC") enter this Agreement, effective April 1, 2021, in order to facilitate the transfer of students from WSCTC to LC and to support their academic success in their choice of the following LC Degree Programs:

- Business Administration, AS
- Business Studies, AS

### AREAS OF AGREEMENT:

This Agreement will be applicable for students who have completed the Diversified Occupations Program and wish to pursue one of the degrees listed above at LC.

This Agreement will not be applicable to students entering LC with limited credits or students transferring without completing the Diversified Occupations Program.

Students must complete the WSCTC Diversified Occupations Program with a grade point average of 3.0/4.0 (85% or above) in all program courses.

Under terms of this Agreement, students completing the Diversified Occupations Program will be admitted to their choice of programs listed above at LC on the condition that they abide by this Agreement.

Students who have completed the Diversified Occupations Program would be granted credit for the following course: ***BUS 105 Introduction to Business (3 credits)***

LC reserves the right to accept/deny students into the Degree Programs listed above.

### CONDITIONS OF THE AGREEMENT:


1. The LC Director of Admissions, LC Programs of Study Coordinator and Recruiter, and the West Side Career and Technical Center Director will monitor compliance with the terms of this Agreement.
2. Either institution may withdraw from this Agreement upon written notification directed to the other, except that commitments already in effect for students who have applied to LC will be honored. In the event of a substantial breach, such as, a lack of response to requests for information and a lack of adequate participation, either party may immediately terminate this Agreement.
3. The relationship of the parties to this Agreement shall not be construed to constitute a partnership, joint venture, or any other relationship, other than that of independent contractors.

4. Neither of the parties shall assume any liabilities as a result of this Agreement. As to liability to each other or death to persons, or damages to property, the parties do not waive any defense as a result of entering into this contract. Nothing herein shall be construed as a waiver of any immunities afforded by LC by law or otherwise.
5. This Agreement represents the entire understanding between the parties. This Agreement can be modified only in writing with the same formality as the original Agreement.
